CALL FOR PAPERS

"The European Financial System in the post-Covid perspective"

The Italian Society affiliated to the European Society for Banking and Financial Law invites its members and, more generally, scholars of banking and financial law and the economics of financial intermediaries to present research work at the 2021 Annual Conference, "The European Financial System in the post-Covid perspective", organized in collaboration with the Milan Branch of the Bank of Italy and the Faculty of Banking, Financial and Insurance Sciences of the Catholic University of the Sacred Heart, which will take place on 26 November 2021, at the Milan Branch of the Bank of Italy, or online if the conditions will not allow physical meetings.

Legal and economic scientific works on the following subjects will be taken into consideration:

- Moratoria and public guarantees
- Crisis Code and Restructuring Directive
- Banking aggregation processes
- Concentration and the principle of proportionality
- Emergency measures adopted by the EU for the capital market
- SMEs and access to trading venues
- Role of "new" investment organizations in supporting growth (private equity, credit UCITS, infrastructural funds, ELTIF)
- Capital markets and digitalization
- Evolution of the post-pandemic market abuse discipline

The purpose of the Call for Papers is to encourage the submission of works - of a critical or empirical nature and not simply of a descriptive nature - that aspire to be the subject of presentation and discussion at the Conference.

PAPER SUBMISSION

The deadlines are as follows:

- by **September 20, 2021**: submission of the abstract as an e-mail attachment (to aedbf.segreteria@gmail.com) in order to submit it to a peer review; the abstract must be at least 3000 characters long and contain a brief description of the subject of the paper and the issues that the author intends to address;
- by October 4, 2021: communication of admission to the AEDBF Annual Conference;
- by **5 November 2021**: sending the complete paper by the same means and to the same address.

For admission purposes, works in both Italian and English languages will be considered.

In the case of contributions involving more than one author, the identification of a corresponding author is required to identify the author in charge of the submission of abstracts and papers. Any communication from AEDBF (acceptance, rejection of the paper, etc.) will be addressed to such author only.

PUBLICATION OPPORTUNITIES

When submitting abstracts, the authors should declare whether they would like to have their papers considered for publication in a Special Issue of "Journal of Financial Management, Markets and Institutions" edited by a prestigious international publisher (World Scientific Publishing Corporation). These papers will be subject to a separate reviewing process after the conference.

Please note that submitted papers dealing with (i) legal issues (written in French or English) may be sent to the "Revue Internationale des Services Financiers" published by the Belgian publisher Bruylant and (ii) economic and legal issues (written in Italian) to the journal "Banca Impresa Società" published by Il Mulino. These papers will also be subject to an independent refereeing process after the conference.

In the hope of a wide and widespread response to our Call, we extend to all our warmest greetings and best wishes for a good job.
