"Ten years of financial innovation: an assessment"

The Italian Society affiliated to the European Society for Banking and Financial Law invites its members and, more generally, scholars of banking and financial law and the economics of financial intermediaries to present research work at the 2019 Annual Conference, "Ten years of financial innovation: an assessment", organized in collaboration with the School of Banking, Financial and Insurance Sciences of the Università Cattolica del Sacro Cuore, which will take place on 22 November 2019 in Milan, at the headquarters of Banco BPM.

Legal and economic scientific works on the following subjects will be taken into consideration:

- Impact of new technologies on markets (infrastructure, high-frequency trading and products)
- Crypto-asset, token e ICOs
- Evolution of the business models of banking and financial service providers in the light of technological developments (open banking and platform services)
- Technological evolution, outsourcing and perimeter of supervised entities
- Crowdfunding equity- e lending-based
- Invoice trading
- Technology and evolution of banking, financial and investment services
- Impact of new technologies on services and payment systems
- FinTech
- Impact of artificial intelligence on banking and financial activities
- Evolution of the activity and of the RegTech and supervisory tools

- Technology and evolution of non-banking business financing products.

The purpose of the Call for Papers is to encourage the submission of works - of a critical or empirical nature and not simply of a descriptive nature - that aspire to be the subject of presentation and discussion at the Conference.

The deadlines are as follows:

- by 31 July 2019: submission of the abstract as an attachment to an email (to aedbf.segreteria@gmail.com) in order to submit it to a peer review; the abstract must be at least 3000 characters long and contain a brief description of the subject of the paper and the issues that the author intends to address;
- by 10 September 2019: communication of admission to the AEDBF Annual Conference;
- by 20 October 2019: sending the complete paper by the same means and to the same address.

For the purposes of admission, works in both Italian and English languages will be considered.

In the case of contributions involving more than one author, the identification of a corresponding author is required to identify the author in charge of the submission of abstracts and papers. Any communication from AEDBF (acceptance, rejection of the paper, etc.) will be addressed to such author only.

In the hope of a wide and widespread response to our Call, we extend to all our warmest greetings and best wishes for a good job.
